

# Travelling to and from the UK for work in Film or High-end Television Drama Production During COVID-19

This guidance summarises government regulations relating to international travel and should be read in conjunction with <u>'Working Safely During COVID-19 in Film and High-end TV Drama</u> <u>Production'</u>.

# **Travelling to the UK**

## Coronavirus (COVID-19): Travel Bans and Mandatory Hotel Quarantine

Cast and crew who have, in the last 10 days, been in or transited through countries on the Government's <u>travel bans list</u> will be refused entry to the UK. This does not apply to cast and crew who are UK or Irish nationals and third country nationals with residency rights (e.g. who hold an appropriate visa) - in such cases, from 15 February 2021, entry to England, Scotland and Wales will be permitted on the basis of compliance with mandatory requirements as follows:

- They will need to present a negative pre-travel COVID-19 test result, taken in the three days before arrival
- On arrival they will need to quarantine (self-isolate) in a government-approved quarantine hotel for 10 days

Before they travel, they will need to book their hotel and two COVID-19 tests to take during their quarantine (tests to be taken on days two and eight of quarantine with a provider that meets UK government <u>minimum standards</u>). More information on how to book quarantine hotels and tests can be found <u>here</u>.

<u>WALES</u>: There are no designated ports of entry in Wales, therefore cast and crew must arrive through one of the designated ports of entry in England or Scotland and isolate for 10 days in a managed quarantine hotel before onward travel to Wales.



**<u>SCOTLAND</u>: All cast and crew** arriving into Scotland from anywhere outside the Common Travel Area are subject to mandatory hotel quarantine.

Current UK designated ports of entry are: Aberdeen, Birmingham, Edinburgh, Farnborough, Gatwick, Glasgow, Heathrow and London City airports.

**NORTHERN IRELAND:** There is no requirement to test on days two and eight of self-isolation if a traveller is arriving in Northern Ireland, although they must complete the 10 days of self-isolation. However, in line with rules for England and to assist with passenger checks, travellers arriving into England before transiting directly to Northern Ireland must book COVID-19 tests for days two and day eight of self-isolation, although these tests do not need to be taken.

Always check the relevant guidance for each nation before travel.

### Coronavirus (COVID-19): Testing for People Travelling to the UK

Passengers arriving into the UK from all international destinations must present a negative COVID-19 test result, taken in the three days before arrival. This applies to all cast and crew, including UK citizens. The test, test provider and certificate must meet the required standards for pre-departure testing - details can be found here for England, Northern Ireland, Scotland and Wales.

Those entering England will additionally need to <u>book two COVID-19 tests</u> before they arrive, to take during their quarantine, and will need to quarantine at home for 10 days.

Individuals travelling to England from countries not on the travel bans list may still opt into the <u>Test</u> to <u>Release</u> scheme, as outlined below.

#### Coronavirus (COVID-19): Travel Corridors

Travel corridors are currently suspended. Always check before you travel.

#### Coronavirus (COVID-19): Test to Release for International Travel - APPLIES TO ENGLAND ONLY

The Test to Release for International Travel scheme is for cast and crew who need to self-isolate on arrival in England. Under the scheme, cast and crew can take a private COVID-19 test with a provider that meets UK government <u>minimum standards</u>. The earliest they can take a test is five full days after arrival in England. If the result is negative, they can stop self-isolating.

The Test to Release scheme is voluntary and applies to those self-isolating in England only.

If cast and crew opt into Test to Release, they must still take additional tests on days two and eight after their arrival - see '**Testing for People Travelling to the UK'** above.

Test to Release is not available to anyone who has been in or through <u>any country that is subject to a</u> <u>travel ban</u> in the 10 days before their arrival in England.

If cast and crew do not want to opt in to test to release, or are travelling to Northern Ireland, Scotland or Wales, they will need to self-isolate for 10 full days.



### Coronavirus (COVID-19): British Qualifying Film and HETV Exemption

As of 4am GMT Monday 18 January 2021, the Film and HETV Travel Self-isolation "Quarantine" Exemption, along with other screen exemptions and Travel Corridors, has been suspended. Further detail can be read <u>here</u>.

All international arrivals who departed from, or transited through, any country outside the <u>Common</u> <u>Travel Area</u>\* in the previous 10 days will be required to both take a pre-departure COVID-19 test and self-isolate immediately for 10 days on arrival, as stated above. Those who qualify for the <u>Test to</u> <u>Release scheme</u> (England only), as stated above, can reduce their self-isolation period from 10 days to five days.

\*Northern Ireland only: for travellers from the Common Travel Area, the travel self-isolation exemptions for film and television still apply in Northern Ireland. This means that, providing the travellers have not left the Common Travel Area in the previous 14 days, they can continue to move between their accommodation and one place of work. # **Travelling from the UK**

### Coronavirus (COVID-19): Declaration Form for International Travel - APPLIES TO ENGLAND ONLY

From 8 March 2021, passengers travelling abroad from England outside the Common Travel Area will need to carry a new travel declaration form stating that their trip is permitted under COVID-19 restrictions. The form must be downloaded and signed before travel, and carried or downloaded onto a mobile phone. More information can be read <u>here</u>.

## If you get coronavirus (COVID-19) symptoms while in the UK

You should look for any of the following symptoms during your 'bubble' period and throughout your stay in the UK:

- new continuous cough
- high temperature
- anosmia (loss or change to your sense of smell or taste)

If you develop symptoms you must self-isolate for at least 10 days from when your symptoms started until you are better and no longer have a high temperature.

If you have a high temperature you must continue to self-isolate even if:

- you have had and recovered from other coronavirus symptoms in this time
- you get a negative test result for coronavirus

Alert your production immediately on noticing symptoms. They will advise you of their symptom response plan, including when and how to seek medical assistance, and help to arrange an appropriate coronavirus (COVID-19) test for you.

If your test is positive you will be asked to share your contacts with the <u>NHS test and trace service</u>. Your contact detail declaration may be used to alert people who travelled to the UK alongside you.



Anyone who is not experiencing symptoms but tests positive for COVID-19 must self-isolate for at least 10 days starting from the day the test was taken.

Anyone who tests positive whilst not experiencing symptoms, but develops symptoms during the isolation period, must restart the 10-day isolation period from the day they first develop symptoms.

#### If a co-worker or close contact gets coronavirus (COVID-19) symptoms

If you come into close contact with an unconfirmed case while working in the UK, you will not need to self-isolate until the case is confirmed. However, you should take extra care in practising social distancing and good hand and respiratory hygiene, and be more alert to any symptoms you might develop, until the test result is known.
